### GW Policy on Outside Aid

Federal law and institutional policy require that need-based aid be adjusted when additional aid or outside resources are received. Outside resources are considered to be part of the need based award package. The only exception to this is for new students who are awarded an outside scholarship after May 1st in which case it will be applied towards any unmet need. Note that tuition-based scholarships and grants cannot exceed full tuition when combined, nor can all aid received exceed the estimated cost of attendance. If there is an excess, GW awards will be adjusted to these limits.
